

Kristine Geary's December 5, 2024 email, copied to the Prime Minister, the Leader of the Official Opposition, the Leader of the NDP and media in NWT and Canada; copy posted:

A. The posted email does not ask questions about the *Final Self Government Agreement for the Tłegohłı Got'ıneę* or the *Tłegohłı Got'ıneę Government Constitution* which are the two documents that members are being asked to vote on on March 31, 2025:

A-1 No information about the contents of either the *Final Self- Government Agreement* or the *Constitution* has been withheld at earlier member engagement meetings in 2022, 2023 or 2024, or at the September 27 – 28, 2024 AGM, or at the November 29, 2024 Yellowknife Information Meeting.

A-2 The audited financial statements of the Tłegohłı Got'ıneę Government Incorporated for fiscal 2023 – 2024 were presented to Members at the AGM on September 27, 2024 and copies had been and were sent to every Member by mail and email.

Since at least 2011 all of the financial statements for the corporation have been presented at each AGM and copies have been sent to Members by mail and email.

A-3 Arrangements have been made to provide a Zoom Link for the December 13, 2024 Edmonton Information Session and are being made to provide a Zoom Link for the January 11, 2025 Vancouver Information Session.

A-4 Contribution Agreements for our self-government negotiations and to pay for the ratification process are reported in the

Tłegohłı Got'ineę Government
Incorporated's audited financial statements
but copies of those contractual agreements
are not shared with Members – neither do
Members get copies of any other contracts
that the corporation enters into.

None of those contractual agreements or
other contracts contain any information
relevant to the question to be voted on by
the Tłegohłı Got'ineę on March 31, 2025.
That question being: Do you approve and
ratify both the *Final Self-Government
Agreement for the Tłegohłı Got'ineę* and the
Tłegohłı Got'ineę Government Constitution?

A-5 The historic or current membership of the
Tłegohłı Got'ineę self-government
negotiating team (2006 – 2024) is not
information relevant to that question, but it
is common knowledge that:

Larry Tourangeau served as Chief Negotiator from 2006, through the signing of the Framework Agreement on June 13, 2007 and the signing of the Agreement-in-Principle on January 16, 2019, until 2020.

Ethel Blondin Andrew has served as Chief Negotiator since 2020 and had also attended earlier negotiation meetings.

Margaret McDonald has served as a negotiator from the beginning.

Ruby McDonald attended earlier negotiation meetings until her death.

Cece McCauley attended earlier negotiation meetings while serving as President of the Land Corporation.

Sherry Hodgson attended earlier negotiation meetings while serving as Vice-President of the Land Corporation and has attended all negotiation meetings while serving as President of the Land Corporation.

Geoffrey Grenville-Wood served as legal advisor from 2006 until his death. Kathryn Dykstra served as legal advisor from 2010 – 2011 until she retired. David Rolf has served as legal advisor since 2011.

Jess Fortner served as technical advisor from 2006 until retiring from the Land Corporation. Paul Tan has served as technical advisor since 2011.
